# ACHIEVE INSPIRE CONNECT

**Our mission** is to create opportunities for high-potential students from low-income households to define their individual paths through high school, college, and career, ultimately benefiting the lives of others.

**Our vision** is equity in opportunity for all students.

Access Opportunity was founded in 2014 to expand access to the academic, social, and professional opportunities that higher-income students often take for granted.

Our six-year program begins the summer before 11th grade and follows students through college graduation, offering personalized support every step of the way. We believe that first-generation students and students from low-income households have earned more than a path to college – they’ve earned the tools, relationships, and support to thrive through college and into a meaningful career.







### 11th Grade – 1<sup>st</sup> Year of College

- Personalized college counseling and cohort support
- Community-building and self-discovery
- Academic skills development
- Support with transitioning to college



### 2<sup>nd</sup> – 4<sup>th</sup> Year of College

- \$10,000 for educational expenses
- Career assessment, education, and development
- Personalized career counseling and cohort support
- Support with preparing for life after graduation

Through **Access College**, students receive one-on-one college advising, academic support, career exploration, and social-emotional development as they navigate the application process and prepare for the transition to college.

Once in college, **Access Career** provides continued counseling, internship and job search support, leadership development, and networking opportunities to help students explore their interests and launch successful careers.

**Social-emotional learning** is embedded throughout the program, and we partner closely with families to ensure they feel confident supporting their students. We also work to amplify student voice by inviting students to shape workshops, lead events, and share their stories as they define success on their own terms.

Our students are trailblazers. They're not only changing the trajectory of their own lives, but also creating new possibilities for their families and communities.

# Meet Ramon

## AO Class of 2029 Incoming First-Year at CU Boulder

Senior year was a whirlwind of classes, work, and scholarship applications, but underneath the deadlines and essays was a deeper motivation. His mother, who passed away before he finished high school, had left school herself after elementary school to help raise her siblings.

**“It would be kind of a waste of her sacrifices if I didn’t try my best to do the one thing she asked: go to school.”**

Taking on adult responsibilities early, like managing household tasks, caring for his younger brother, and making sure bills were paid, taught him to plan ahead and persevere, even when the path wasn’t easy.

That persistence paid off. With support from AO, Ramon secured multiple scholarships, including the funding that will allow him to attend CU Boulder without worrying about tuition. As he prepares to move into his dorm, the milestone hasn’t fully sunk in, but he’s ready for what’s ahead.

**“I didn’t realize how amazing the program would be and how much it would help me, until now I’m going into college. Going to college, trying your hardest, living your best life, that’s what it’s all about. I have a future in my hands.”**

### Incoming Sophomore at Wesleyan University



When Batt arrived at Wesleyan, she was ready to build a home for herself far from the one she grew up in.

**“I was nervous about leaving home to go so far away and not knowing anyone... but I was mostly excited to be making a home for myself, learning new subjects, joining new clubs, and meeting new people.”**

Her first year was full of exploration: she discovered a love for psychology, thrived in the vibrant music and student band scene, and built a close community starting with her roommate, who became her closest friend. Wesleyan’s First Things First program for first-generation students helped her navigate campus culture early, and she now gives back as a counselor for the same program.

Balancing sleep, studying, social life, and clubs wasn’t easy, but Batt leaned on careful planning, upperclassman advice, and the support of AO.

**“Applying to Access Opportunity and receiving their support helped me realize these dreams. My counselor’s support, affections, and advice have helped me navigate all the confusion and challenges of my first year.”**

She’s proud of the friends she’s made, the goals she’s achieved, and her growing confidence to give back. In AO, she has served as a Student Advisory Group member for the past two years and is now stepping into a peer mentor role.

Her advice to other students: **“Although change is scary, it will allow you to grow. Research the programs your school has to support you, and don’t be afraid to ask for advice from those who’ve been there.”**

## Meet Eli

For Eli, one of the most pivotal moments in his AO journey came during his final Summer Workshop, at our annual Cal-Wood retreat.

**“Watching my classmates – people I had known for six years – stand before me as the confident, capable leaders they had become genuinely brought me to tears. It was beautiful, not only to witness their growth, but also to reflect on my own transformation over the years.”**

It was a moment to celebrate their growth, and his own, while passing on lessons and advice to younger AO students. That carried into his time at Colorado School of Mines, where he built leadership skills, deepened his sense of identity, and pursued opportunities that would bring him closer to his dream of working in aerospace engineering.

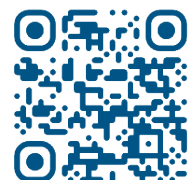

Entering the University of Colorado Law School



Yatzari has always been drawn to politics, social justice, and law, passions shaped by her experiences growing up in a low-income community as the daughter of immigrants. She sees the law as a tool to dismantle unjust systems, strengthen protections for the vulnerable, and repair harm. That vision, and years of perseverance, led to her acceptance at her top-choice law school with a full ride.

**“I read the email on my phone and burst into tears so hard my family thought something horrible had happened. When I finally shared the news in between sobs, everyone cried with me. Even my macho uncles who I had never seen cry before.”**

Her journey wasn't without setbacks. After graduating college, she took two gap years to save money, prepare for the LSAT, and build the confidence she needed to make law school a reality. Along the way, AO helped her navigate the process, overcome imposter syndrome, and connect with a community of peers who inspired her.

Now the first AO alum to be accepted to law school (and the first to have two younger siblings in the program!), she's eager to mentor others considering the same path.



**“AO believed in my potential before I could ever see it. They helped me see that I was capable of achieving anything I set my mind to. For this, I will be forever grateful.”**
